BROADCAST MESSAGE (UP TO 5 PAGES, 12 LINES PER PAGE, 76 CHARACTERS PER LINE):

Last year, ICBC introduced manually-invoiced Assessment & Report fees which included any assessments required for that date of service, including visits billed to MSP with the MVA flag, which indicates ICBC responsibility for payment.

When MVA-flagged visits were billed to MSP and the invoice was sent separately to ICBC for the Assessment & Report, ICBC would refuse the visit, triggering a refusal of any associated billing of 13075 for unrelated conditions.

As a temporary measure while a long-term solution is implemented, MSP will accept all billings of 13075 without the visit fee retroactive to April 1, 2019. Practitioners must now resubmit all claims for 13075 that have been incorrectly refused due to this issue since that date. MSP has granted pre-approval to bill any of these claims older than 90 day using submission code A.

The oldest claims must be submitted no later than September 30, 2020, so please start rebilling your earliest outstanding claims and work forward.
