Mandate

The Family Practice Services Committee (FPSC) is a partnership between the Ministry of Health and Doctors of BC. The committee collaborates with family physicians to encourage and enhance full-service family practice and benefit patients.

FPSC is composed of 12 representatives, six from the Ministry of Health and six from Doctors of BC. BC Family Doctors nominates <u>three</u> of the six Doctors of BC family physician representatives on the Committee.

Responsibilities

The FPSC Committee works to:

- Identify changes in current physician service delivery that could result in improvements in patient care, more effective utilization of physician and other health care resources, and measurable savings in expenditures that could be reallocated for more optimal provision of healthcare services:
- 2. Support the integration and alignment of physician services with other health service delivery;
- 3. Strengthen the application of Triple Aim principles in service design and delivery;
- 4. Encourage appropriate collaborative practice with other physicians and integration of physicians with other healthcare professionals in the delivery of services;
- 5. Identify gaps in care and address population health needs;
- 6. Support the delivery of quality and evidence-based care including promoting the adoption and effective implementation of appropriate clinical practice guidelines where appropriate;
- 7. Prior to making decisions, consider the unique issues arising from rural practice;
- 8. Use total expenditure data for services as an aid to making decisions;
- Form temporary sub-committees (that may be allocated a specific budget) where required to address issues of patient care which engage the mandate of more than one Joint Clinical Committee;
- 10. Make recommendations on appropriate shared care between physicians and other healthcare professionals; and
- 11. Establish measures for accountability and achievement of outcomes.

Terms and Time Commitment

Term of Office: FPSC members serve 3-year terms which are renewable for a second 3-year term. The term will begin in January 2025.

The time commitment for FPSC is significant. The time commitment includes:

 collective views and interests of all family doctors in British Columbia, not simply those of their
 region, compensation mode or unique practice characteristics.
- Have experience on Boards or committees of BC Family Doctors, Doctors of BC, and/or Divisions of Family Practices.
- Be knowledgeable about the history, political dynamics and structure of Doctors of BC and Joint Collaborative Committees.
