BC Family Doctors is looking for one (1) Family Physician Doctors of BC Caucus Member for the Family Practice Services Committee (FPSC), who will also represent the FPSC at collaborative tables in one of the five health regions. Any Doctors of BC/ BC Family Doctors member who meets the qualifications is welcome to apply. Given the current composition of the FPSC Doctors of BC Caucus, *preference may be given to applicants located in rural settings or Northern Health regions and Indigenous applicants.*

Mandate/Objective of the Committee:

The Family Practice Services Committee (FPSC) is a partnership between the Ministry of Health and Doctors of BC. The committee collaborates with family physicians to encourage and enhance full-service family practice to benefit patients.

FPSC is composed of 12 representatives, six from the Ministry of Health and six from Doctors of BC. BC Family Doctors nominates three of the six Doctors of BC family physician representatives on the Committee.

FPSC programs support the delivery of primary care services to British Columbians through, among other things:

- integrated and collaborative initiatives;
- identifying and supporting physicians, patients and communities with unmet needs;
- providing support for Family Physicians to provide full-service family practice;
- improving capacity for quality, access and attachment in primary care;
- enhancing comprehensive and continuous care; and
- improving coordination and quality of care to family practice patients in BC.

The FPSC has a strategic focus on supporting community longitudinal Family Physician practice through incentives and supports, strengthening the Patient Medical Home (PMH) as the foundational building block of primary care, and resourcing and supporting the Divisions of Family Practice. The PMH describes an ideal, team-based family practice enabled through technology, business models, and practice level coaching and support to provide longitudinal, comprehensive, coordinated care to a defined panel of patients over time. This provides the foundation for delivering patient care within a broader, integrated system of primary and community care, as expressed through Primary Care Networks (PCNs).

Member Role and Responsibilities:

At the committee level, FPSC physician representatives represent BC Family Doctors and ensure that the Doctors of BC/ BC Family Doctors Directive and interests are represented at the joint partnership table.

As part of their role as FPSC committee members, FPSC physician representatives also link directly with the regional Interdivisional Strategic Council (ISC), attend key member events, and will be supported by staff to be a resource to divisions for matters requiring FPSC input. In this way, they help to provide a linkage to core FPSC decision makers and share matters requiring input from the FPSC.

At these tables, FPSC physician representatives speak on behalf of and represent the collaborative committee voice. FPSC physician representatives and FPSC Primary Care Transformation Partners (PCPTs) work together to ensure that divisions are supported in their work and are linked to broader primary care transformation initiatives.

Terms and Time Commitment

Term of Office: FPSC members serve 3-year terms, which are renewable for a second 3-year term.

The time commitment for the FPSC is significant. Approximate time commitments include:

***Though not a significant and regular time commitment, FPSC members attend other primary care related groups, meetings and conferences as required, based on expertise, availability, and interest.*

Honoraria for FPSC related work related is paid by FPSC/ Doctors of BC, as per the Honoraria and Expense policies.
